We are getting an increasing number of forms faxed to our office which need to be completed, but as they are not on line they are not fillable. What are the proper programs for making a form fillable?

Adobe Acrobat (Pro DC). Tell the senders to stop sending via fax and have them email the forms.

I use Acrobat X Pro. It has a feature to type on PDFs. Only issue is that you now often have to flatten the PDF to save the typed annotations.

I just discovered this week that the free Adobe Reader allows you type text on a .pdf and then save it. It works on most .pdfs that I have received lately. There is an icon on the horizontal menu at the top of the screen that looks like a paper and a pen. Click that, and then an option to add text will appear on the right side of the screen. This will allow you to add text on top of the .pdf, but you cannot edit the original .pdf. Works well for fill in the blanks.
